



assigned to, or is otherwise available to any person or entity other than the Original Purchaser, will void both Warranties in their entirety and release Arcadia, Inc. from all obligations hereunder.

2. Each Warranty applies only to Product delivered for use in the continental United States of America unless expressly stated otherwise.

3. Each Warranty applies only if the Product is installed in accordance with Arcadia, Inc. recommended care and maintenance instructions delivered to the Original Purchaser with the Warranty, and with the specific installation instructions regarding prevention of corrosion set forth below.

(a) Galvanic Corrosion: Whenever dissimilar metals are in contact or close proximity with each other there is a potential for a chemical reaction that causes corrosion. The potential is increased in the presence of an electrolyte such as moisture, and especially salt water. To decrease this potential, Arcadia, Inc. recommends the following. (i) During installation, separate dissimilar metal by placing inert materials between them. (ii) Strictly follow the cleaning and maintenance instructions described in Section 4 below and particularly, whenever finished areas are exposed to moisture, dry those areas as quickly as possible. (iii) If the builder or architect design requires the joinder of dissimilar metals, use one material that is weaker than the other metals to act as an anode to draw the electrons that cause corrosion to it and away from the other materials, and always consult with your builder or architect to make sure appropriate joinder materials are used.

(b) Caustic Corrosion: During installation the Product must be protected from chemicals that might damage exposed aluminum, hardware or the finish. The most common contaminant is stucco run-off and concrete splashing. Exposed aluminum is especially susceptible to construction site chemical contamination. To minimize damage from such contamination, if the Product is exposed to such chemicals during the Job construction, clean all contaminated areas immediately, and in all events, all Products must be thoroughly cleaned immediately after installation and at Substantial Completion.

Any deviation from Arcadia Inc.'s recommended installation instructions, including the instructions in (a) and (b) above, immediately voids both Warranties in their entirety and releases Arcadia, Inc. from all obligations hereunder and all liability with respect to the Product. In no event shall Arcadia, Inc. have any liability to, or for costs incurred by the Original Purchaser to, repair, replace or re-install any product that has not been properly installed as a result of any deviation from Arcadia Inc.'s recommended installation instructions, including the instructions in (a) and (b) above.

4. Each Warranty applies only if the Product is cleaned and maintained in accordance with Arcadia, Inc. recommended cleaning and maintenance instructions delivered to the Original Purchaser with the Warranty and with the AAMA 609 and 610 Cleaning and Maintenance Guide for Architecturally Finished Aluminum, and only if the Original Purchaser has signed an acknowledgment of receipt and review of a copy of Arcadia, Inc.'s cleaning and maintenance instructions and such Guide. Specifically, but without limitation, anodized finishes should be cleaned with mild soap (not a detergent) and water solution annually and semi-annually for finishes located near the ocean or other sea water. In no event shall Arcadia, Inc. have any liability to, or for costs incurred by the Original Purchaser to, repair, replace or re-install any product that has not been cleaned or maintained as required herein.

5. The Warranties do not apply to any defect or failure of the Product to perform as warranted when such defect or failure is caused, in whole or in part, by any handling by the Original Purchaser that is contrary to



customary industry practice or otherwise improper, including but not limited to, with respect to transportation, storage, erection, fabrication or placement.

6. The Warranties do not apply to, and Arcadia, Inc. hereby disclaims all liability for, the use or installation with the Product of any operating hardware, other parts or components, gaskets, glass, glazing materials or other finishes or sealants of other manufacturers, and Arcadia, Inc. shall have no responsibility nor liability for any such products nor any failure in the performance of the Product attributable in whole or in part to such items or their use or installation with the Product.

7. The Warranties do not apply to, and Arcadia, Inc. hereby disclaims all liability for, the selection of the Product for any particular project or design configuration, and Arcadia, Inc. expressly disclaims any warranty or representation that the Product will perform for any particular project or design configuration; that determination is the sole responsibility of the Original Purchaser to make. Further, the Original Purchaser acknowledges that laws and building and safety codes governing the design and use of glazed entrance, window and curtain wall products vary widely, and Arcadia, Inc. expressly disclaims any warranty or representation that the use of the Product in any particular project or design configuration will comply with laws and federal, state or local building and safety codes governing such project or design configuration; again, that determination is the sole responsibility of the Original Purchaser to make.

8. The Warranties, and specifically the Limited Finish Warranty, only apply to finishes that are exposed to normal weather conditions, and do not apply to: (i) finishes exposed to corrosive atmospheric conditions such as those contaminated with chemical fumes, salt spray or mist, acid rain or temperatures which cause the paint surface temperature to exceed 200 degrees Fahrenheit, (ii) galvanic or caustic corrosion; or (iii) any finish degradation or damage caused by exposure to chemicals such as acids or alkalis, or by moisture, condensation or other contamination resulting from improper packaging, handling, processing, storage, installation or exposure to staining water.

9. The Warranties do not apply to, and Arcadia, Inc. hereby disclaims all liability for, any Product which becomes defective due, in whole or in part, to falling objects, building or foundation settlement or other movement, accident, fire or other casualty, explosion, riot or other civil disturbance, flood, earthquake or earth movement or other acts of God, acts of war, vandalism, or any other occurrence beyond the control of Arcadia Inc., or depreciation or normal wear.

WARRANTY CLAIMS

Each Warranty applies only to defects or failures in performance first appearing within the Product Warranty Period or the Finish Warranty Period, as applicable, and only if Arcadia, Inc. is notified in writing within sixty (60) days after the Original Purchaser first knows, or with the exercise of reasonable prudence should know, that such alleged defect or failure exists.

The Original Purchaser is responsible to maintain adequate records to: (i) establish the dates of receipt and installation of the Product, and the date the Original Purchaser first had knowledge of any defect or failure regarding such Product or its finish, for which any claim under either Warranty is made; and (ii) demonstrate that the defect or condition allegedly covered by the applicable Warranty was due to breach of such Warranty as provided herein and was not due to other causes, including causes excluded under the limitations and conditions herein. Arcadia, Inc. shall have no liability for any claims under either Warranty for which the Original Purchaser does not establish, to Arcadia Inc.'s reasonable satisfaction, any of the foregoing.



Arcadia, Inc. shall be given a reasonable opportunity to inspect the Product alleged to not be in conformity with a Warranty and Arcadia, Inc. shall have no liability under a Warranty unless and until it is given such opportunity and, within a reasonable time following notice of the defect or non-conformance, Arcadia, Inc. has performed such inspection. All decisions regarding the existence of defects in material or workmanship or any failure of warranted conditions of the anodized finish, and whether such defects or failures are the result, in whole or in part, of any causes excluded under the limitations and conditions herein, shall be made by Arcadia, Inc. in its reasonable judgement and shall be final and binding upon the Original Purchaser.

LIMITED LIABILITY

In the event that, following a Warranty claim timely delivered by the Original Purchaser, a Product or finish warranted herein is determined to not be in compliance with the applicable Warranty, Arcadia, Inc. shall have the right to elect one of the following as the Original Purchaser's sole and exclusive remedy for any breach of warranty or other claim that the Original Purchaser has or may have as a result of such defective Product or non-conforming finish:

(a) To repair or replace the defective Product, or refinish the non-conforming finish. If Arcadia, Inc. elects to exercise such right of repair, replacement or refinishing, Arcadia, Inc. shall: (i) have the right to select a contractor and negotiate a contract, or to approve a contractor selected by and/or a contract negotiated by the Original Purchaser, to perform any repair or refinishing work, at a price also negotiated or approved by Arcadia, Inc.; and (ii) cause such repair, replacement or refinishing to be completed in a commercially reasonable time. In the event Arcadia, Inc. repairs, replaces or refinishes any Product, the applicable Warranty shall remain in effect for such repaired, replaced or refinished Product only for the remainder of the Warranty Period applicable to the original Product or its finish.

(b) To refund to the Original Purchaser the monies paid by the Original Purchase for the Product for which the Warranty claim is made, or if the Original Purchaser's claimed losses resulting from the defective product or non-conforming finish are less than full monies paid for the Product, Arcadia, Inc. may refund a portion of such payment equal to the Original Purchaser's claimed losses.

The remedy selected by Arcadia, Inc. shall be the sole and exclusive remedy under each Warranty or for any other claim arising from or in any way relating to defects in or any other condition or use of the Product or its finish covered by the Warranties, however caused, and regardless of whether any such claim is based upon warranty, contract, negligence, including negligence in manufacturing or design, strict liability or any other theory, the remedy for such claim is limited to repair, replacement or refinishing of such Product or repayment by Arcadia, Inc. of all or part of the monies paid to it for the Product, each as provided herein.

IN NO EVENT SHALL ARCADIA, INC. BE LIABLE FOR SPECIAL, PUNITIVE, DIRECT, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES OF ANY KIND, INCLUDING BUT NOT LIMITED TO LOSS OF USE, LOSS OF PROFITS OR REVENUES, LOSS OF GOOD WILL, OR OTHER COMMERCIAL LOSS OR INJURY, WHETHER OR NOT ARCADIA, INC. HAS BEEN ADVISED OF OR IS OTHERWISE ON NOTICE OF THE POTENTIAL FOR SUCH DAMAGES. BY ITS SIGNATURE ON THE ACCEPTANCE OF WARRANTY BELOW, THE ORIGINAL PURCHASER HEREBY WAIVES ANY RIGHT TO SEEK OR RECOVER ANY SUCH DAMAGES AND AGREES THAT ITS REMEDIES FOR ANY BREACH OF EITHER WARRANTY OR FOR ANY DEFECTS IN OR FAILURES IN PERFORMANCE OF THE PRODUCT OR ITS FINISH SHALL BE SOLELY AND EXCLUSIVELY AS SET FORTH IN SUBPARTS (a) AND (b) ABOVE.



The Warranties are the only warranties made in connection with the sale and distribution of the Product and its finish. Arcadia, Inc. makes no representations nor warranties whatsoever, either express, implied or statutory, relating to the Product or its finish except as expressly set forth herein, and Arcadia, Inc. hereby expressly disclaims all such representations and warranties, including but not limited to any implied warranty of merchantability or fitness for a particular use or purpose of the Product or its finish. By its signature on the Acceptance of Warranty below, the Original Purchaser hereby acknowledges the foregoing disclaimer, and further acknowledges and agrees that, except as expressly set forth herein, neither Arcadia, Inc. nor anyone acting for or on behalf of Arcadia, Inc. has made any representation or warranty, either express, implied or statutory, with respect to the Product or its finish, except as expressly set forth herein, and the Original Purchaser hereby waives all such representations and warranties.

In the event of any dispute, claim or disagreement (collectively, "*Claims*") arising under either Warranty, Purchaser and Arcadia will mediate such Claims before commencing any judicial proceeding with respect thereto. The mediation shall be conducted in Los Angeles County, California, at a time and place and with a mediator selected by mutual agreement of the parties. The mediation fee, if any, shall be divided equally between the parties involved. Before the mediation begins, the parties involved shall sign a document limiting the admissibility in any other mediation, arbitration or any other judicial proceeding of anything said, any admission made and any documents prepared in the course of the mediation consistent with California Evidence Code Section 1152.5. Notwithstanding anything in this Paragraph to the contrary, the following Claims are excluded from the requirement of mediation: (a) the filing or enforcement of a mechanic's lien; (b) any matter which is within the jurisdiction of a probate court; or (c) an action filed to enable the recording of a notice of pending action, for order of attachment, receivership, injunction, or other provisional remedies.

TO THE FULLEST EXTENT NOT PROHIBITED BY LAW, BY ARCADIA, INC.'S DELIVERY AND THE ORIGINAL PURCHASER'S ACCEPTANCE OF THIS WARRANTY, EACH PARTY WAIVES ITS RESPECTIVE RIGHTS TO A JURY TRIAL OF ANY CLAIM OR CAUSE OF ACTION BASED UPON OR ARISING OUT OF THIS WARRANTY OR ANY DEFECT OR NON-COMPLIANCE WITH THIS WARRANTY OF THE PRODUCT OR ITS FINISH.

Each Warranty, its validity, construction, interpretation, enforcement and the rights of the parties hereto shall be determined under, governed by and construed in accordance with the laws of the State of California, without regard to principles of conflicts of law. By signing the Acceptance of Warranty below, the Original Purchaser agrees that all actions or proceedings arising in connection with this Warranty or in any way related to the Product or its finish shall be litigated in courts, mediated, or arbitrated if the parties agree to such procedure, exclusively in the County of Los Angeles, State of California.

In the event that any provision of this document conflicts with applicable law, such conflict shall not affect other provisions of hereof that can be given effect without the conflicting provisions, and to this end the provisions of this document are severable.

To be valid, each Warranty must be signed by an officer of Arcadia, Inc.; no employee, representative or dealer of Arcadia, Inc., or other person other than an officer of Arcadia, Inc. is authorized: (i) to make any warranty, representation or promise with respect to the Product or its finish other than as provided herein and signed by an officer of Arcadia, Inc.; or (ii) to alter, add to or otherwise modify the terms or provisions of either Warranty unless such modification is approved and signed by an officer of Arcadia, Inc. No warranty, representation, promise, term or condition other than those stated herein shall be binding on Arcadia, Inc. unless made in writing and signed by an officer of Arcadia, Inc. Any modification of this document not signed



by an officer of Arcadia, Inc. shall void both Warranties in their entirety, and Arcadia, Inc. shall have no further liability hereunder.
